

The Rules of Golf as administered by Golf Canada prevail for tournament play.

Penalty Areas:

A red stake or line designates a RED Penalty Area. A yellow stake or line designates a YELLOW Penalty Area.

Hole 13: balls entering either red or yellow penalty areas may be played from the drop zone provided under penalty of 1 stroke.

Out of Bounds:

Defined by white stakes.

Three R's:

Please REPAIR ball marks on greens, REPLACE divots, and RAKE sand bunkers.

Pace of Play:

The pace of play should be 2 hours or faster for each nine holes. The

Alternative to Stroke and Distance local rule applies. 2 stroke penalty.

Yardages:

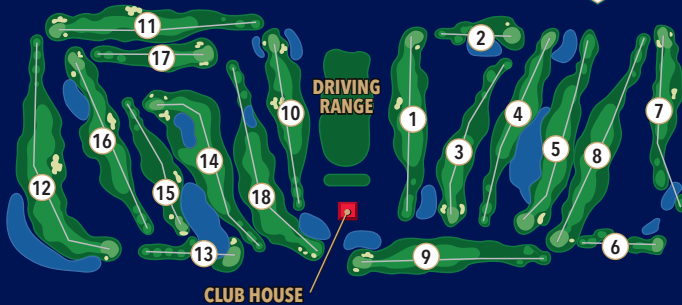
Yardage markers and sprinkler heads are measured to the centre of the green.

Naturalized Areas:

Areas of tall grass are not hazards unless specifically marked as such.

Local Immovable Obstructions:

Yardage disks, constructed pathways, bridges, stairways, tee markers, signs, sprinkler heads, sprinkler control boxes, flower beds and staked trees are all immovable obstructions. Drop within one club length of the closest point of complete relief, but not nearer the hole. No penalty.
